Call to Order

Mayor Julie Smith called the meeting to order at 5:30 PM.

Approval of the Agenda

Council Member Reynolds made the first motion for approval of the agenda, the motion seconded by Cromer, and unanimously approved.

Presentations

Downtown Update

Main Street Director Hillery Culpepper gave an update on the success of the Farmers Market in Downtown; over 1000 attendees, 28 vendors, 10 sold out at the spring grand opening! Tift Theatre Director Kezia Larry also spoke on the recent concert and comedy show held at the Theatre, mentioning the events brought roughly 200 attendees. She also mentioned the Theatre has an R&B Night and a pageant upcoming.

New Business

Ryland Environmental – Proposed Contract Amendments

Aaron Sowa w/ Ryland Environmental presented a proposed three-year contract extension (January 1, 2026 - December 31, 2028) at a flat rate of \$18.02 per home and \$4.50 per cubic yard for commercial, with a fuel surcharge adjustment based on fuel prices. Council reviewed the proposal but did not have any comments.

Resolution Designating Arts in Black as a Festival

Ms. Melissa Hughes and Mr. Garfield Rainey were present to seek the City's promotion and designation of the Arts in Black Festival scheduled for May 2 & 3, 2025. The event organizers mentioned they have submitted their special event permit and requested approval to allow alcohol sales at the event planned at Fulwood Park. Council reviewed the information submitted.

Proposed Amendments to the City's Flood Ordinance

Loretta Hylton, Planning & Zoning Director, presented proposed updates to the City's Flood Ordinance. She mentioned the proposed changes were necessary to meet the standards of the **National Flood** Insurance Program to ensure local the floodplain management program is consistent with Flood Zone Amendments.

Adoption of the Revised FEMA Flood Insurance Study Report and Flood Maps

Ms. Hylton provided Council with the updated flood study and maps prepared by FEMA. She mentioned the maps will officially go into effect August 19, 2025 but need to be adopted by the City.

Recommendation for Expanding the City's Enterprise Zone

Jessica White, City Clerk, presented a staff proposal to expand the city's enterprise zone to include primarily commercial areas in the South Tifton redevelopment area. She mentioned the expansion was suggested by Mayor Smith to include focus areas of the URA for redevelopment. A proposed map of the areas was included but Ms. White welcomed any changes to the proposal.

Review of Proposed Amendments to the City's Alcohol Ordinance for Catering

Jessica White, City Clerk presented a proposed ordinance amendment to provide clear guidance and limitations on alcohol catering and special event permits. Staff recommended limiting alcohol catering events to six annually per organization and three days maximum per event. Ms. White mentioned that special event permits are intended for temporary one-time events, but due to the lack of defined limitations, allows repeated use and circumvents the original intent. Council reviewed the proposed amendments.

Consider Appointments to the City's Board of Ethics

Rob Wilmot, City Attorney, discussed the process needed for appointing members to the City's Board of Ethics. He mentioned the City Council would need to appoint two members, and the other members would be appointed by the Tifton Bar Association and the Superior Court Judge. He mentioned he is working with the Bar Association on their appointments and encouraged Council to be thinking of residents to appoint to the board.

Other Business

Board Report

Council reviewed the board report, which showed positions with expiring terms for 2025.

City Manager Report

Larry Lawrence highlighted recent police and fire calls and activities, and gave a status update on public works projects. He also mentioned a lease cancellation letter was sent to TCCCY for their current space, and he is waiting to hear back if they accept the City's alternative space at the Youth Center.

Executive Session

Council Member Hall motioned to go into executive session to discuss legal matters. The motion was seconded by Council Member Reynolds and unanimously approved. The meeting closed to executive session.

Resolution Providing for Executive Session

Council Member Lester Cromer motioned for approval of the resolution, seconded by Council Member Hall and unanimously approved.

There being no further business to discuss, the meeting adjourned.
