Call to Order

Mayor Julie Smith called the meeting to order at 5:30 pm.

Approval of the Agenda

Council Member Reynolds made the first motion for approval of the agenda, motion seconded by Hall, and the agenda was unanimously approved.

Public Hearing

Zoning Public Hearing on Application PP25-0011, Submitted by Johnathan Garvey, Requesting to Rezone 0.45 Acres Located at 305 E. 22nd Street from General Business (GB) to Residential (R-10) to Construct a Single-Family Home – Map & Parcel T052 143B

City Attorney, Rob Wilmot, opened the public hearing, introduced the application, reviewed the zoning procedures, and asked the Council Members the following conflict questions to determine their eligibility for participating in the hearing.

- 1. Have any of the applicants or opponents to applications contributed at least \$250 to any of the campaigns for election during the past two years? Everyone stated no.
- 2. Do you or any members of your family own property that would be impacted by these classification applications whether that be a positive impact or a negative impact? Everyone stated no.
- 3. Do you or any members of your family have an interest in a business that would be impacted by these classification applications whether that be a positive impact or a negative impact? Everyone stated no.

Mr. Wilmot asked that the record reflect that the Council Members present did not have any conflicts of interest and were eligible to participate in the hearing.

Loretta Hylton, Planning and Zoning Administrator, gave details on the proposed rezoning request in which the applicant is requesting the property be rezoned from General Business to Residential for construction of a single-family dwelling. Ms. Hylton mentioned the property is currently vacant, and the developer will be responsible for running water and sewer to the property. The zoning staff report concluded that the proposed development was suitable for the area and consistent with the City's Comprehensive Plan. The rezoning request was also submitted to the Planning & Zoning Commission for review and was unanimously approved. The public hearing opened to public comment, but no one spoke, and the hearing was closed

Presentations

Proclamation for Foster Care and Foster Family Recognition Month

Mayor Julie Smith read aloud the proclamation and presented it to Rebecca Thomas with Coastal Plan CASA. Mayor Smith thanked Ms. Thomas and her team for all their work in advocating for children in foster care.

Proclamation for Mental Health Awareness Month

Mayor Julie Smith read aloud the proclamation and presented it to the community mental health providers and advocates present. Mayor Smith expressed her gratitude to those working in the field and thanked them for their dedication and service.

NEW BUSINESS

Festival Designation Request for Juneteenth Celebration

Latasha Howard provided details about the Juneteenth celebration and requested the Juneteenth celebration be recognized as a festival and allow alcohol sales during the event. The non-profit, Jake's Hands Inc., is organizing the event, which is planned for June 7, 2025, at Fulwood Park. The Council reviewed the request but did not have any further questions.

Resolution Approving the 2025-2026 SRO Agreement with Tift County Schools

Steve Hyman, Chief of Police, emphasized the importance of having School Resource Officers to ensure children's safety and presented the proposed agreement for continuing to partner with Tift County Schools and assign SROs at multiple schools for the 2025-2026 school year. He explained that the presence of an SRO not only helps deter potential threats and criminal behavior but ensures a sense of safety among students, staff, and parents. Based on the proposed agreement, the school system will cover the officers' salaries and benefits, up to \$168,702.22.

Review of Zoning Application for PP25-0011, Submitted by Jonathan Garvey, Requesting to Rezone 0.45 Acres Located at 305 E. 22nd Street from General Business (GB) to Residential (R-10) to Construct a Single-Family Home – Map & Parcel TO52 143B

The Council Members reviewed the rezoning request, but did not have any questions to follow. (see zoning public hearing for more details)

Mosquito Control Update and Discussion

Larry Lawrence, Acting City Manager, presented an inspection report from the Georgia Department of Agriculture on Astro's Mosquito Control Program for Tifton and discussed that Astro was 100% in compliance with the Georgia Department of Agriculture's Regulations.

Larry Lawrence gave a summary of upcoming events, projects, and updates for the City of Tifton.

Mayor & Council Comments

Councilman M. Jay Hall mentioned the success of First Friday and how much he and his family enjoyed the event.

Mayor Julie Smith presented the Railway Spike from the City of Waycross. During the Hurricane, the City of Tifton lent Waycross generators for their water system, and this assistance was vital in keeping their

community with running water. Mayor Julie Smith also spoke on the Georgia Small Cities conference coming to Tifton this week and reviewed the events planned.

Executive Session for Personnel Matters

Council Member Hall made the first motion to go into executive session to discuss personnel matters. The Motion was seconded by Reynolds and unanimously approved. The meeting closed to executive session.
